The compact design of the connector allows for it to be used even where mounting conditions are tight and enable quick installation. Thanks to the integrated mounting bracket, PS3 quick connectors can be installed and removed without the use of tools. Assembly also can take place during fully automated processes. An integrated gasket ensures the proper tightness.

NORMAPLAST SV hose and pipe connectors connect plastic pipes such as PA6 and PA12 pipes. They are made of black polyamide 6 or polyamide 12 with 30 percent glass fibers and can be supplied with Orings.
